**ISSUE AND BACKGROUND:**

Three special events highlighting televised college football games were held in 2023 at the Market Village with each drawing a large crowd. One of the city's large LED screens was placed in market village and a means of legally broadcasting games was secured along with games and entertainment for the participants. The 2024 dates will follow the same formula using the following timeline for each event. As televised game times are published, there may be some slight adjustment to the game start with each date, or it may follow the same timing. (Promotion cannot include the names of teams and/or conferences).

3:00 pm – Gates Open (no admission)

3:30 pm – 1<sup>st</sup> game is televised on the LED screen

3:30 pm to 7:00 pm – Entertainment with games and prizes

7:00 pm – Watch another big college game!

Street closings include the upper circle area of the Market Village that includes the fountain area and generally includes a designated pedestrian area within and around the fountain and adjoining parking areas to the left and right of the fountain, including the drive and parking spaces between the fountain and Atlanta Road. Parking spaces in front of Atkins Park and Zucca's Pizza are designated for parking the LED screen trailer. The main area street closings begin at 9:00 a.m. on September 28, October 19, November 16, and December 7. Additional street closing may be accomplished in response to attendance after event start which includes a plan for vehicle parking attrition and access restrictions, but only as/if needed. The plan includes three street closure phases with Phase 1 (9:00 a.m. on each day) being the closures as described above. Phase 2 and 3 would include portions of or all of the access from the fountain down to streets adjacent to the center median in the Market Village from the fountain/event area down to the cable company and the broker/financial advisor offices. This plan is in place to avoid impacting access to businesses within the Market Village for an
