**E. 2024-084 Coordinator's Report – *Eloise***

- Document Shredding: 18,000 lbs collected from 396 vehicles. Thanks to the 16 volunteers that helped! Julie noted a very steady flow of traffic the entire time. Next shredding event in September
- School Tours continue: 107 students attended in the past month. This included age appropriate recycling activity and paper making.

**F. 2024-085 Committee Reports – *Phyllis / Dawn as acting Chair***

1. **Garden Tour Committee:** Covered in Old Business section
2. **Education Committee:** A motion was passed to increase the amount provided to the two 2024 scholarship winners from \$1,500 to \$2,000. A discussion about increasing the school grants was brought up by the education committee, there was a lot of discussion but it ran over time so it was tabled until the May meeting. This may be topic to finalize during 2025 budget setting in the Fall.
3. **Pollinator Garden Committee:** **No update since pausing until after Garden Tour.**
4. **Audit:** No updates pending next quarter's audit. Completed July - November in December.
5. **Fundraising and Grant Committee:** Liv provided an update. Corporate sponsorship approach to reference 40th Anniversary to solicit new sponsors for KSB general fund in honor of 40th anniversary and recognizing future work such as Pollinator Garden in 2025. We do need to raise significantly more donations this year by Q4 to elicit Town Council for remainder of required funding. City budget voted on in December. We intend to share capital costs with the City and recognize they will maintain the park after its built.

**G. 2024-086 Director's Report – *Julie***

- Keep Cobb Beautiful: Upcoming Sustainability Forum. Julie will have booth at the forum.
- Recycling Pricing Update shared.
- Cardboard continues to increase (\$80/ton)
- Mixed paper actually drawing a payment (\$32/ton) though remains very low to zero
- Office Paper dropped slightly.
- PET declined but steady past year
- HDPE Color up to \$100/ton; HDPE Natural staying steady
- Mixed Metal more volatile and now about \$140/ton; Aluminum cans highest amount per ton (½ ton in 40 yd roll off container)
- Glass remains steady
- No income from paint or electronics because disposal paid by City directly
- Program Assistant role still under recruitment
- City is doing a rebranding exercise. ([LINK](#) previously shared by Julie)
