The proposed sign exceeds both the maximum area (32 square feet) and maximum height (8 feet) specified by the ordinance, is not a ground based monument sign as required by the ordinance and is a pole sign as prohibited by the ordinance.



The proposed sign exceeds both the maximum area (32 square feet) and maximum height (8 feet) specified by the ordinance, is not a ground based monument sign as required by the ordinance and is a pole sign as prohibited by the ordinance.

- Welding electrodes and compounds shall be AWS E70T-1 (Current Edition), E70T-1.
- Design Wind Speed= 110 MPH (100 c.f.)
- Equivalent Wind Load= 20.2 PSF @ 40'-0" above the ground. (3) See Wind Detail.
- Equivalent Snow Load= 20.0 PSF.
- Soil Bearing Capacity Requirements shall be 5.0 c.f.
- Clear or Net Floor Area (Unobstructed) shall be 150 SF x 20,000 P.S.F. per foot of width. (See drawing for details)
- Contractor shall verify all dimensions and conditions in the field before erection and notify the Engineer of any discrepancies.
