The City of Smyrna has received an annexation request under the 100% method for 0 Dixie Ave, Parcel Id 17049100410, approximately 0.21 acres, with a Cobb County zoning of HI (Heavy Industrial) and Industrial Compatible Future Land Use. The applicant plans to annex the property and rezone (Z24-016) to MU (Mixed Use) with a MU (Mixed Use) Future Land Use. The 0.21 acre parcel will be assembled with several other parcels for the development of 295 multi-family units, and a civic building of approximately 30,000 sq. ft. on approximately 9.8 acres.
