## 4. Review of Current M&C Agenda

### A. **PRE2023-028** Review of the December 4, 2023 Mayor and Council Meeting Agenda

Mayor Pro Tem Gould reviewed the December 4, 2023 Mayor and Council meeting agenda.

Brief discussion took place regarding tabling the PoolPak item (2023-223) in order to purchase the equipment first which will take approximately 20 weeks for delivery. While waiting for the equipment, the City will bid out for installation and have an installer ready when the equipment arrives.

Brief explanation of item ATH2023-55 for the City's Worker's Compensation Program, Joe Bennet, City Administrator, stated that because the HR team is short-staffed and does not have a designated person for Worker's Comp issues, the best alternative is to contract through the City's insurance plan that has devoted resources which reduces the City's exposure and allows the City to gain a risk management team.

No further discussion took place.

## **5. Other Business / Staff Comment**

Councilmember Welch asked how short-staffed the police department currently is. Mr. Bennett stated they are around 10-12 short. Mr. Welch asked if there is anything further that can be done to promote the police department better. Discussion took place about how most neighboring communities are also very short-staffed, the many efforts the City has taken to retain officers already (pay increases, better benefits, bonuses, retirement, etc.), the continued negative culture surrounding police officers.

Councilmember Lindley mentioned the Highland Rivers open house. They offer many services, and he encouraged everyone to visit and see all they have done and all that they do in the community. It is geared toward youth populations but not exclusively, and they are very engaged in Cobb County.

Joe Bennett, City Administrator, updated the Council on the following:

- Drywall is up on Council Chambers
- Pressure is being put on the vendor who is providing soundproofing panels
- Administration hall is nearly ready for everyone to move in
- Village Green Park – pad for the stage has been poured
