### 2. Call to Order

Mayor Derek Norton called to order the August 3, 2023 Special Called City Council meeting held at A. Max Bacon City Hall in the HR Training Room at 6:30 PM.

### 3. Formal Business

- A. 2023-150** Public Hearing and adoption of the 2023 Millage rate and authorize the Mayor to sign and execute all related documents.  
**Citywide**

Mayor Derek Norton opened the public hearing.

Gregory Brown, 508 Micayne Circle, came forward and read aloud from a prepared statement. The following are highlights from his statement:

1. Increase Revenue Sources – local sales tax increases, tourism taxes, etc.
2. Economic Development – EV charging stations, manufacturing, etc.
3. Implement Cost-Saving Measures – energy efficient initiatives, public-private partnerships, etc.
4. Collaborate with Regional Partners – share services like public transportation or waste management, etc.
5. Engage in Long-Term Financial Planning – regular financial assessments, multi-year budget plans, etc.

6. See Community Input and Transparency – engage with businesses and the community, etc.
7. No increase in millage rate should be implemented

Mayor Norton thanked Mr. Brown for his thoughts. He explained that many of the suggestions Mr. Brown made are good and are already being implemented, and Mayor Norton stressed that the millage rate is not increasing for homesteaded properties. It has been at 8.99 since around 2004, but the state legislature requires that a tax increase be advertised if the City keeps the millage rate the same but the tax digest grows. There will be no increase for homestead exempted properties. The confusing wording is prescribed by the legislature.

Mr. Brown added that he would like the City to do a better job of communicating the good things that are happening in the City because so many residents are not aware of the measures that are being taken to save money.

Mayor Norton closed the public hearing.

Councilmember Travis Lindley made a motion to approve item 2023-150, a public hearing and adoption of the 2023 Millage Rate and authorize the Mayor to sign and execute all related documents; seconded by Mayor Pro Tem / Councilmember Tim Gould.

The motion to approve carried with the following vote:
