**ISSUE AND BACKGROUND:**

Current City owned sewerage pump station serves 100 homes in the area to pump its sewerage from low point on Belmont ave to gravity fed line that feeds to Cobb County treatment facility. Pump station pump one experienced failure a few weeks ago posing emergency operation plan to be put in place until new pump one is installed. At this time water sewer is relying on one pump to operate every hour on the hour putting unnecessary strain on the existing pump.

Staff recommends approval for purchase of replacement pump for pump station located at 1327 Belmont Ave Smyrna, Ga 30080 in the amount of \$56,302.20 funded from Water Sewer CIP FY2025 to Xylem Water Solutions USA, Inc. located at 90 Horizon Drive Suwanee, Ga 30024 and authorize Mayor to sign and execute all related documents.
