## 2. Call to Order

Mayor Derek Norton called to order the June 5, 2023, Pre-Council Meeting held at the Smyrna Community Center in the Oak Room at 6:31 PM.

## 4. Review of Current M&C Agenda

**PRE2023-016** Review of the June 5, 2023 Mayor and Council Meeting agenda.

Mayor Norton reviewed the Mayor and Council agenda.

Discussion took place on item 7B. **ORD2023-006** Public Hearing - Approval of ORD2023-006 for amendments to the Code of Ordinance in relation to notification requirements for variance requests, special land use permits, administrative appeals and the Urban Design Commission and authorize the Mayor to sign and execute all related documents. City Attorney Scott Cochran explained that this needs to be done prior to July 1, 2023, to be in compliance with the state. Zoning decisions are legislative, and appeals are made directly to superior court. Variances are quasi-judicial, the state has a procedure on how the decision of the board is reviewed which means appeals go to superior court. If variances are embedded in zoning, the Mayor and Council are still involved. Council was concerned that minor variances cannot be appealed to the Mayor and Council. Mr. Cochran stated

the city could add an additional layer to the appeals process at a later date so it can go before the Mayor and Council, but for these purposes, to be in compliance with the state, this amendment needs to be approved. Russell Martin, Community Development Director, stated that most appeals to variances are neighbor disputes.

Penny Mocer, Deputy City Administrator, explained for item 9D. **RFQ2023-13** Approval to award RFQ 23-013 Fanny Williams Legacy Project to the team of David Wilson, Stephen Hayes, and Michael Gonzales for their proposed design, Testimony of Redemption for \$125,000, and to authorize the Mayor to sign and execute all documents, that the draft contract has been sent to legal for review. What is built into that contract is that design amendments/changes can be made throughout with the Committee to Honor Fanny Williams.

Eric Randall, Public Works Director, explained for item 9E. **AGR2023-015** Approval of the Framework Agreement with Cobb County to fulfill role as Project Administrator with Georgia DOT for South Cobb Improvement Project and authorize the Mayor to sign and execute all related documents, there is language structured to allow for a breaking point and the city assume control of the project.
