ISSUE AND BACKGROUND:

The City of Smyrna is hosting an all-day festival titled Culture & Spirit Festival in conjunction with the 151st Birthday Celebration. For the purpose of this all-day festival and annual City of Smyrna celebration, much of the downtown area has been approved for street closings for the festival and the main concert that will take place on Atlanta Road. All alcohol sales will take place within the approved event boundaries. Premier Events and City Park Concessions have been designated as festivities organizers for the Culture & Spirit Festival and will be managing a portion of alcohol and concession sales, with the exception of those stations to be individually managed and operated by the existing Market Village merchants who currently hold alcohol licenses within the City of Smyrna and will be conducting sales in front of their businesses. The City of Smyrna is issuing permission for the above mentioned businesses and respective owner/operators to seek a State permit for the purpose of ordering product and managing their individual business sales as well as manage their respective insurance requirements for the activity.

Additionally, Atkins Park Tavern (Kevin Drawe) will operate an alcohol sales (beer) station/tent at two locations beyond his business premises – 1) station at King Street/W. Spring Street across the street from City Hall, and 2) a station on/at King Street adjacent to the Community Center (as specified by event organizers).
