It requires an extra taxation for commercial properties, and he is not sure there is any benefit for the City of Smyrna to be involved in that because any funds are directly used for those projects in the CID.

Discussion took place about the polling places for the municipal elections being held on November 7, 2023.

Councilmember Lindley asked when City Hall will be ready. Mayor Norton said he heard that Administration should be back in there around Thanksgiving. Council Chambers are waiting for acoustic panels before being able to go back in there for meetings.
