ISSUE AND BACKGROUND:

Application was made for privilege license agent change for GB License LLC, dba goPuff for the sale of beer & wine (retail package). Terry Landon Peterson is the agent applicant.

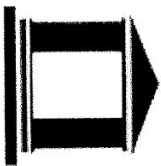
