**ISSUE AND BACKGROUND:**

Application was made for privilege license agent change for Route 46 Management Associates Corp., dba Hyatt Place Atlanta Cobb Galleria, for Pouring of Liquor, beer & wine. Jacqueline A Foley is the agent applicant.

Jacqueline A Foley will be the registered agent responsible for sale of alcohol at 2876 Spring Hill Pkwy SE, Smyrna, GA 30080. The applicant has been given a copy of the Alcoholic Beverage ordinances and attended the mandatory alcohol awareness workshop.

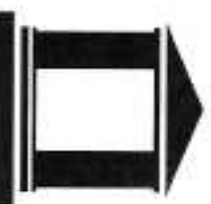
