Call to Order

Mayor Pro Tem Tim Gould called to order the February 8, 2024 Committee of the Whole meeting held at A. Max Bacon City Hall in the HR Training Room at 6:30 PM.

A. COW2024-003 Cambridge Mobile Telematics – Get Home Safe Program

Ben Hendricks – Cambridge Mobile Telematics – presented the following:

This would cost approximately \$47K annually. This fee would allow Smyrna to access the data pulled about driver habits/behavior in the city as well as statewide and identify hot spots and concerns around the city. Concerns were expressed about its usefulness because primarily responsible drivers would be downloading the app, not those who are speeding or violating traffic laws. Further discussion will take place at a future time.

4. Review of Current M&C Agenda

Mayor Norton resumed as chair of the meeting.

A. COW2024-008 Review of the February 12, 2024 Mayor and Council Meeting Notice and Agenda

- Joey Staubes, Planner II, provided the background for item Z24-001. Councilmember Lindley recused himself from this item because he sits on the executive board of the church:

STNL Development LLC is requesting a rezoning from R-15 (Residential) to LC-Conditional (Limited Commercial) for the ability to construct a 7,000 sq. ft. veterinary clinic and 10,000 sq. ft. day care facility. The subject property is zoned R-15 and has been used for an institutional purpose as a church. The existing building will be demolished for the construction of a new veterinary clinic and day care facility on two separate parcels. The veterinary clinic parcel is 1.1 acres and the day care facility parcel is 1.8 acres. The buildings will be two stories with a maximum height of 26 feet. The project consists of a 10 ft. landscape buffer along the sides of the property adjacent to residential.

The veterinary clinic building will require two variances with respect to residential setbacks. Veterinary clinics require a setback of 100 feet from any residentially zoned property, and any non-residential building requires a setback of 50 feet from any residentially zoned property. The veterinary clinic requires a reduction of those setbacks to 40 feet. However, no outdoor kennels are proposed for the clinic, and the closest adjacent use is a church. Therefore, Community Development believes there should be no negative impact if the reduction is approved.

The proposed building will utilize stone, EIFS, and metal and cement paneling for the front façades. The applicant has provided architectural renderings with the zoning application for reference.

The applicant is providing 81 parking spaces, which is greater than the minimum parking requirement of 68 spaces.

The City Engineer has reviewed the proposed rezoning with respect to transportation, stormwater management and stream buffer issues. There are no stream buffers affecting the property. The development will utilize a detention pond for stormwater management. The main entrance will be right-in and right-out for access to Concord Road. The City Engineer does recommend obtaining an inter-parcel access agreement with the adjacent church to connect the property with Brown Road to reduce U-turn movements on Concord Road and improve access to S Cobb Drive.

- Discussion took place about the waterline replacement items and the contractor being used. Councilmember Welch stated that he has had a positive experience with the contractor, Smith Pipeline Inc.

- Paul Osburn, Assistant Public Works Director, discussed the GA Power Green energy initiatives:

As part of the GA Power green energy initiative as well replacing old end-of-life equipment throughout the city this request is to be able to have a consistent and uniform HVAC and lighting program. This will help in the future for ongoing maintenance, replacement, and budgeting schedules.

Payment Schedule:

5-Year Monthly Power Bill Fee = \$210,853 per month
7-Year Monthly Power Bill Fee = \$161,081 per month

This would be a two-and-a-half-year project. Mayor Norton asked that this be postponed so that they can discuss this more and look at the budget further.

- Scott Cochran, City Attorney, spoke about item ATH2024-036. The City previously approved a downtown concept plan that includes a parking deck on the site of the current records center building on Atlanta Road, approved the plan for the deck, awarded a construction Manager at Risk to Winder Construction Company for the build of the deck and allocated SPLOST funds for construction of the deck on that location. Based on subsequent circumstances, and other redevelopment planned within the downtown area, the City believes that the deck should not be built on this parcel.

- Ashley Youmans, Special Project Manager, discussed the challenges the Fanny Williams Legacy Project is facing when finding contractors. Three contractors responded. They are consulting with the one they would like to go with to make sure their numbers will stay firm so as to ensure that there will be no change orders – their submission was a little confusing so they would like to clear some things up. They would like to bring in the contractor to clarify their submission and have the runner-up contractor on standby just in case the original contractor does not work out. Mayor Pro Tem Gould will speak with Mr. Osburn and Ms. Youmans tomorrow before moving forward.

- Deputy Chief Mark Binicewicz discussed the need to replace four totaled police vehicles. The Police Department needs to replace three (3) pursuit utility vehicles that were previously wrecked. The Police department has reusable equipment (cages and radio consoles) that can be fitted on new 2023 vehicles. The option to reuse our existing equipment will save time and money as the turnaround time for new equipment is 4 to 5 months. Police and Purchasing contacted Wade Ford, Allan Vigil Ford, and Phil Brannen Ford for availability of vehicles. Wade Ford has 2024 pursuit vehicles on order that could be delivered sometime in March, but the models are not compatible with the reusable equipment. Allan Vigil Ford did not provide information. Phil Brannen Ford has three (3) 2023 models available that are compatible with our reusable equipment and can be delivered as soon as possible. Phil Brannen Ford 2023 Ford Pursuit Utility - \$43,471.00 per vehicle \$130,413.00 Wade Ford 2024 Ford Pursuit Utility - \$42,902.00 per vehicle \$128,706.00.

5. Other Business / Staff Comment

Joe Bennett, City Administrator, updated the Maor and Council on the following:

- John R. Carmichael, Sr. of Carmichael Funeral Homes passed away.
- Upstairs library restroom toilet was flushed too hard with the foot. It leaked for several minutes. It has been repaired.
- Richard Garland met with Winter Const. to look at the Downtown Park and how the water issue can be repaired.
- A potential assassination attempt on Chief Zgonc was made. An individual brought in some documents to headquarters who asked to speak to Chief Zgonc. Two officers escorted him from the front to the back of the police department. There was a substance on the documents that caused the officers to feel sick, almost pass out, have chest pain, heavy sweats, etc. The FBI is still investigating to determine what the substance may have been. The individual has been arrested. The two officers are recovering well.

Councilmember Oglesby attended the well-attended open house for the beltline extension. There will be a town hall in March.

Councilmember Pickens said that many residents upset about the train noise may attend the council meeting to ask the city to do more about the noise. Mayor Norton expressed frustration that there is nothing more the city can do because it is out of Smyrna's jurisdiction legally.

Councilmember Welch stated that Fire Station #2 needs to have the dirt removed from the front of the building. He also stated that he will not be present at the next COW meeting.

Mayor Pro Tem Gould reminded all of the Smyrna Public Safety Gala on Saturday.

Councilmember Hines reminded all that February 23, 2024 is the Black History Month Celebration. She also stated that Smyrna's Parks & Rec is better than anyone else's Parks & Rec with all of their great activities.
