Councilmember Wilkinson stated that she believes it is a good use of the space, but she wonders if they have reached out to the neighboring properties. The land is federally owned or privately owned, therefore, the city cannot legally touch that land.

Councilmember Oglesby stated that last Thursday he attended a meeting about the beltline extension that was very well-attended. Many of the people in attendance were actually not residents of Smyrna. The concerns most expressed were about privacy. There will be a town hall organized very soon. He also shared that he was a guest judge for the science fair at King Springs Elementary.

Mayor Pro Tem Gould said the Public Safety Gala Saturday night was great. The Fanny Williams project is moving forward with the crew that did the landscaping at the Reed House.

Councilmember Lindley mentioned the N. Cooper Lake Park Pavilion looks great.

Mayor Norton announced that Stillfire applied for their LDP Friday, and they should be moving dirt by the end of the month.
