ISSUE AND BACKGROUND:

Application was made for privilege license for B & G trade, LLC, dba Biryani-N-Grill for the sale of Beer, Wine & Liquor (pouring & Sunday sales). Purushotham Kutati the agent applicant.

Purushotham Kutati will be the registered agent responsible for the sale of alcohol at 2590 Spring Rd SE, Smyrna, GA 30080. The applicant has been given a copy of the Alcoholic Beverage ordinances and attended the mandatory alcohol awareness workshop.

The business name is **Biryani-N-Grill**.


The business is incorporated under the name **B&G Trade LLC**.


