ISSUE AND BACKGROUND:

Smyrna is Fabulous was approved to hold the 2024 Annual Pride Festival in the Smyrna Market Village on Saturday, June 22, 2024, from 12:00 pm to 6:00 pm during the January 29, 2024 City Council meeting. Event organizers are requesting to add approval of alcohol pouring to their initial application.

Smyrna is Fabulous plans to partner with Atkins Park Tavern Restaurant & Bar (Kevin Drawe 770-435-1887) to operate a beer, wine, and liquor station during event hours of 12:00PM – 6:00PM. The request details, including the alcohol pouring method and serving location, are outlined in the attached letter. All other event details were included in the organizers' initial application approval.

Please review the provided information for the City of Smyrna to review in Smyrna Is Fabulous' request to have alcohol sold and served (provided by Atkins Park and staff) at the Pride Festival on 6/22/24.

The following information is what our Board of Directors have discussed and what Kevin Drawe/Atkins Park has agreed.

- Drink cart / jockey box will sell beer and wine; A "signature drink" will be offered.
- Hours of service will be during festival hours, 12:00-6:00PM
- Controls plan will be to check ID prior to serving alcohol
- Location will be just east of the Gazebo in Smyrna Market Village on the sandstone paved area between the two W. Spring Streets (approx. 53ft from the gazebo. Please review attached map with location site).
- Atkins Park will provide Smyrna Is Fabulous with COI
- Atkins Park to work directly with City of Smyrna in providing permitting information
