

Proposed Updates to Speed Hump Policy

NEIGHBORHOOD TRAFFIC CALMING POLICY PROCESS



City Engineer Mark Wolff explained the flow chart and the proposed changes.

- Traffic calming only considered for "local streets" or "collector streets" w/ maximum posted speed limit of 35 MPH. Speed humps only considered for streets with posted speed limit of 25 MPH, or less.
 - Add criteria for speed humps only on streets with grade of 8%, or less
- Traffic Thresholds:
 - Volume: Daily average exceeds 1,000 vehicles
 - Speed: 85% of total vehicles exceed posted speed limit by at least 11 MPH.
 - Speed: 5% hides exceed posted speed limit by at least 15 MPH.
 - Unique circumstances may be evaluated by City staff.
 - Revise traffic thresholds from 85% and 5% "of total vehicles" to 85th and 5th "percentile speed"
- Petition Threshold:
 - 60% of property owners affected (or must access the affected street) AND 100% within 100 feet of proposed device.
 - Public meeting / open house?

Mayor Pro Tem Gould expressed that traffic calming measures had not really been done seriously until 2018. And there are many opinions about traffic calming, and that as much as people may hope that these measures are decided democratically, these measures have to be chosen through a more "republic" process. Chairperson Lindley expressed that HOAs need to be participatory in these discussions. If neighborhoods are wanting something placed or something removed, they should be required to come before Mayor and Council to voice their concerns / opinions.
