ISSUE AND BACKGROUND:

New Application was made for privilege license for Taqueria La Villa, DBA Tacos La Villa for the sale of beer and liquor (Pouring and Sunday Sales). Nancy Covarrubias is the agent applicant.

Nancy Covarrubias will be the registered agent responsible for the sale of alcohol at 2415 Cobb Pkwy SE, Smyrna, GA 30080. The applicant has been given a copy of the Alcoholic Beverage ordinances and attended the mandatory alcohol awareness workshop.

A background investigation conducted by the Smyrna Police Department failed to reveal information that would preclude issuance of this license. Mrs Covarrubias has agreed to abide by the guidelines set forth by the City of Smyrna ordinance governing the sale of alcohol.

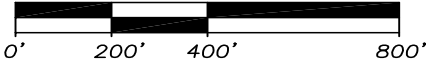
The business name is **Tacos La Villa**.

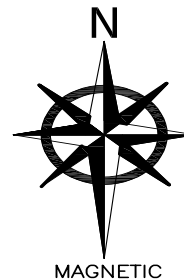

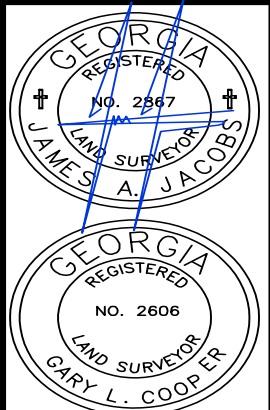
