- A. **2024-210** Consider approval of a Master Bond Resolution, Intergovernmental Economic Development Agreement, and any other documents related to the Authority's Series 2024 Revenue Bonds.

Citywide

Scott Cochran, City Attorney, explained the following:

- This meeting is the first step to get approval for the bond
- Vote to adopt resolution authorizes the city to enter into Economic Development Agreement with the DDA scheduled for August 12
- Validate the bond
- DDA issues the bond, Economic Development Agreement between the city and the DDA is used as security for the payments for the bond, and the city pays the bond
- Validate more than what will actually be issued
- Authorize not to exceed \$16.7M, not to exceed 7%
- Taxable bonds, not tax-exempt, because the plan is to develop the property

- Expectation - \$16.2M at 5 ¾%

Mayor Norton mentioned:

- All three structures on Atlanta Rd. property have asbestos – will need remediation which is probably 60 days out
- Once remediation is complete, demo the buildings
- Looking at early fall
